LHF 2008 Awards

During the Annual Meeting of the Lynchburg Historical Foundation the evening of January 6, the following awards were presented:

Preservation Awards

Larry and Thomas Filiaggi (Exterior Projects in Progress) Christ Episcopal Chapel (circa 1870)

Over the past 138 years this little Chapel has been one of four satellite chapels to serve Grace Memorial Episcopal Church located on Grace Street, a grocery store, the Cabell Street Mission for the Salvation Army, a warehouse for the Standard Notion Company and the New Jerusalem United Holiness Church who transferred it to the Lynchburg Historical Foundation in 1983. LNUF acquired the property and sold it to a private citizen. Larry and his son Thomas purchased the building in 2006 and are restoring the building retaining the historic storefront.

Gary & Sharon Harvey Interior Project Completed 3561 Fort Avenue – (circa 1913)

This house is classified as an Italian Revival with Craftsman style interior oak trim. The interior space is modified from the "four square plan" with a center main stair hall that divides the main level with a large front-to-rear living room to the right and the dining room to the front and the kitchen to the rear on the left. Upstairs three bedrooms and two baths. 10' plaster ceilings with some oak beams/tray ceilings. This house was one of the first in Lynchburg to have purely electric lighting. Most rooms contain the original light fixtures.

Merit Awards (Completed Exterior Project)

Nikole Branch & Jesse Adams-Doolittle 1002 Wise Street (circa 1845)

Curle-Hughes house is one of the oldest houses on College Hill, as its earliest portion was built in 1845 by George Curle, a prominent Lynchburg builder in the decades leading up to the Civil War. Curle sold the house to sisters Sarah Hughes and Edmonia Johnson, who held it in trust for Sarah's daughter until she came of age in 1867. During the Civil War the house was directly opposite the first of many wartime hospitals in Lynchburg, a structure that before the War was the campus of Lynchburg College (no connection to the present institution) and gave "College Hill" its name. In 1942 the Trevey family purchased the house where they lived until the last Trevey resident, Ted Trevey, left in the late 1960s. The house passed through several owners and finally sat vacant from the early-1990s until 2005 when Nikole Branch and

Jesse Adams-Doolittle purchased the house through the Lynchburg Redevelopment and Housing Authority's Homesteading Program. Nikole and Jesse moved into the house in December of 2007.

William Jackson 1118 Wise Street (circa 1906)

Acquired from the Lynchburg Redevelopment & Housing Authority in 2006 this house has seen major renovations.

Lynchburg Museum Director -Doug Harvey 901 Court Street Lynchburg Museum (1855)

The Lynchburg Museum is located in the 1855 Greek Revival court house that overlooks downtown from the top of Monument Terrace. Serving as the City's court house from 1855 until the 1960's, the building had deteriorated over the years. As the City began to plan for the American Bicentennial in 1976, it was decided to restore the court house and open it as a museum for Lynchburg. The Lynchburg Museum opened in the late 1970's and operated until a ceiling collapse in a second floor gallery in 2000 vividly demonstrated the need for further restoration. The building was vacated and fully restored by the end of 2005 and exhibit planning and fabrication took place in 2006-2007. On January 31, 2008, the building reopened to the public. The Museum has won several awards since opening for the restoration, preservation, and quality of exhibits.

Gary & Sharon Harvey 3561 Fort Ave. (1905)

Constructed of clay masonry block molded with keys on both side for bonding of The exterior stucco and interior plaster. Accented with stained brick water table, window surrounds and horizontal accents. The roof structure is a hip roof with green Italian style clay tile and hidden copper gutters. here were originally four exterior porches: front, right, left side/rear and rear. The left side rear porch was enclosed during the recent renovations with the transparency and massing of the original porch configuration maintained with the use of glazed door and window units. The Second Story addition above the open porch, The reconfiguration of the kitchen window and the enclosure of the rear right-side porch were part of the 200-2002 restoration and renovation undertaken by the current owners.

Troy Deacon & Ted Delaney 301 Cabell Street (1873)

One of the first houses constructed during the building boom on Daniel's Hill following its annexation to the city in 1870. The diminutive and delightful front porch occupies the space formed by the re-entrant angle of the

façade. The door and all the windows are topped by shallow rectangular pediments a handsome and perhaps unexpected refinement in a relatively modest house. The house underwent substantial renovations in 2007. The northwest side of the house had to raised ten inches to level the floors, the windows, shutter, roof slates and interior floor boards were all reworked and the house was rewired and re-plumbed.

Karen Kennedy, President, Woodstock Condominium Association and residents 2934 Rivermont Ave. Woodstock Condominiums (circa 1917)

Stanhope Johnson designed the building in 1917. The first and third floors have four apartments each, while the second floor has two mirror image apartments for owners. Allen Chambers said "The Woodstock contains two apartments that were every bit the equal of contemporary private homes." In 1986 developers purchased the building and converted the apartments into condominium. Over the years the Woodstock fell into disrepair with the majority of the problems caused by water damage. In 2002 the resident owners initiated a plan to preserve and maintain the integrity and beauty of the building. In 2007 the work was complete both on the inside and outside totally \$185,000.00 paid solely by the residents.

Preservationist of the Year Award Phillip Wayne Rhodes

Wayne joined the Jones Memorial Library staff in 1981 as the Research Services Coordinator. He held that position for 17 years before becoming the Director of the Library. As director he coordinated the Library activities including personnel, budget, collection development, automation, public relations, etc. He cataloged manuscripts and other materials for the Library collections. For the past 10 years Wayne has moved the Library forward by his professional manner as director and vast knowledge of the Library collections and genealogical records. His publications are to numerous mention individually with his latest being *Free Blacks of Lynchburg, Virginia 1805-1865* co-authored with Ted Delaney, published for the Southern Memorial Association. He has also written many articles and reviews for three major Genealogist Magazine and Journals.
