*The Jones Memorial Library proudly announces three classes for interested patrons this spring*

◆ **Family Tree Maker**

**Saturday, March 28, 2009 from 9:30 – 12:00 a.m.**

Are you new to using your computer to organize your genealogical data? This class will introduce to the Family Tree Maker computer program. You will find out how easily and efficiently you will be able to enter the data, revise it as you find you have new information, record notes and sources, photographs, combine several families with only one common individual, and other ways to make it easier to keep track of what was previously piles of boxes and paper. Jones Memorial Library uses this program for its own Virginia Families Data base of about 150,000 people, and millions of people in America and elsewhere are finding that it is so much faster and easier to share family data with others. Using the program you will also be able to access information on the internet and incorporate it into your own data, or find others working on the same families. We intend for participants in this program to be able to at least become comfortable with the computer for genealogical research. The instructor is staff member Chuck Bradner. The class will take place in the computer classroom of the Lynchburg Public Library.

◆ **Personal Property Tax and Land Tax Seminar**

**Tuesday, April 21, 2009 at 10:00 a.m.**

Looking for that elusive ancestor? Personal Property Tax and Land Tax records may be helpful. When your ancestor has a common name, and there are two persons in the same county at the same time, with the same name how you can tell which is yours? Again, personal property tax and land tax records may solve this riddle for you. These records can supply you also with many clues into the socio-economic status of the family you search.

A seminar on Personal Property Tax and Land Tax records will be presented by Mrs. Giles Wood, whom many of you already know, in the reading room of the Jones Memorial Library on Tuesday, April 21, 2009 beginning at 10 AM and ending at 12 noon. The class will begin promptly at 10 a.m. Please come a few minutes early to take care of name tags, introductions, etc.
